Who We Are

He played a vital role in the Islamic non-interest banks research.
- The Office was also managed by Mr. Abdulaziz Taher Alkhateeb; a vanguard Kuwaiti lawyer who began his career immediately after he registered in the Bar in 1969. Lawyer Khalid Taher Alkhateeb joined the Group during the 1980s bringing with him the latest advanced concepts in the field of law, then came lawyer Jamal Alkhateeb who already had long history and experience in the legal field prior to joining the Group. The Group then attracted another promising dedicated professional, lawyer Fawaz Khalid Alkhateeb, experienced in the laws and regulations of financial markets in the year 2009. 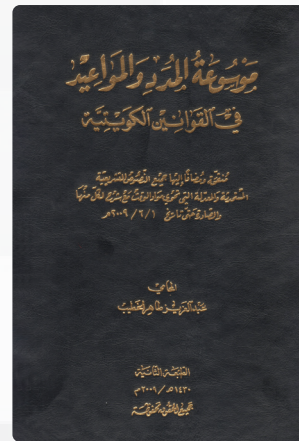
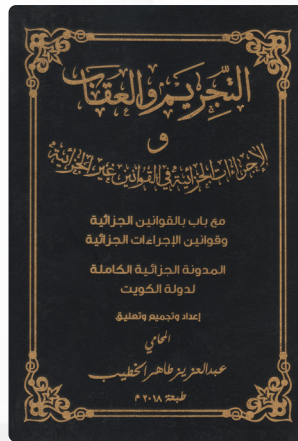

Publications:

- 1- A book titled, "The encyclopedia on the Statute of limitations on the Kuwaiti Laws," by Lawyer Abdulaziz Taher Alkhateeb. The book tackles the time element for raising suits in all the fields of laws with its impacts on rights and obligations. (Presently being distributed by Jareer Bookshop, Kuwait).

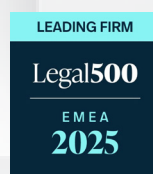
